Sub. :- Inclusion of left out entry of Special Allowance in Schedule-II of Rajasthan Civil Services (Revised Pay) Rules, 2008.

Attention is invited towards FD Circular No. F.16(5)FD(Rules)/98 dated 16.12.2008 regarding inclusion of left out entry of Special Allowance in Schedule-II of Rajasthan Civil Services (Revised Pay) Rules, 2008 upto 31.03.2009. The period of inclusion of left out entry of Special Allowance has been extended upto 30.06.2009 vide FD No. F.11(9)FD(Rules)/08 dated 31.03.2009.

Under Rule 8 of Rajasthan Civil Services (Revised Pay) Rules, 2008, Special Pay has been converted into Special Allowance. Under Rule 9 of the aforesaid rules, Special Allowance has been given in Schedule-II appended to these rules.

It has been brought to the notice of the Government that Treasury Officers are not passing bills of Compensatory allowances like Mess Allowance, Conveyance Allowance, Washing Allowance, Cycle Allowance, Patwar Ghar Allowance and so on, for want of inclusion of these allowances in the Schedule-II of the aforesaid rules, whereas these allowances are not part of Schedule-II and are not to be included in the Schedule-II of the aforesaid rules.

Accordingly, it is clarified that in Schedule-II of aforesaid rules, only Special Allowance and Special Pay converted into Special Allowance is to be included. Other compensatory allowances as stated above are not to be included in the aforesaid Schedule-II and as such Treasury Officers should see that bills of compensatory allowances are not withheld.
