# Sub.: - Amendment in the Rajasthan Work-charged Employees (Revised Pay) Rules, 2008.

The Governor of Rajasthan has been pleased to order that below existing item (i) of Rule 10, the following provisos shall be inserted w.e.f. 01.09.2006, namely: -

"Provided further that in cases where a Work-charged employee has been placed in a higher pay scale between 01.09.2006 and 12.09.2008 (inclusive of both days) on account of grant of selection grade, the workcharged employee may elect to switch over to the Running Pay Band and Grade Pay from the date of grant of selection grade.

Provided further also that where a work-charged employee is due for grant of selection grade after 12.09.2008 and if he so desires to first avail the benefit of next selection grade, in the existing pay scale in force prior to 01.09.2006, in such a case work-charged employee may elect to switch over to the Running Pay Band and Grade Pay under these rules from the date of availing next selection grade, in the existing pay scale. In such cases the excess amount of pay and allowances already drawn on account of fixation of pay under these rules shall be deposited by the concerned incumbent in lump sum.

## Explanation

In such cases on grant of selection grade, fixation of pay will be made as per existing provisions contained in Finance Department Order No. F.16(2)FD(Rules)/98 dated 17.02.1998 and thereafter pay in the running pay band and grade pay shall be fixed under Rule 11 of these rules as per option of the employee."

2. The option under this order shall be exercised by the aforesaid employee in writing so as to reach the specified authority (Head of Office) within 3 months from the date of issue of this order. The option shall be in the prescribed form as appended to the Rajasthan Civil Services (Revised Pay) Rules, 2008.
