In exercise of the powers conferred by sub-section (1) of section 9 of the Rajasthan Stamp Act, 1998 (Act No.14 of 1999), and in supersession of this department's Notification No.F.12(84) FD/Tax/2009-32 dated 18-07-09, the State Government being of the opinion that it is expedient in the public interest so to do, hereby orders that the stamp duty payable on the instruments of lease or sale of residential plot or dwelling unit executed by the Jaipur Development Authority, Jodhpur Development Authority, Rajasthan Housing Board, Urban Improvement Trusts and Municipalities having carpet area not more than 325 square feet in case of Economically Weaker Section, shall be reduced to Rs. 10/- and residential plot or dwelling unit having carpet area not more than 500 square feet in case of Low Income Group shall be reduced to Rs. 25/- on the following conditions, namely :-

- a) that the monthly income of the family, in case of Economically Weaker Section, is not more than Rs. 5000/- ;
- b) that the monthly income of the family, in case of Low income group, is not less than Rs. 5001/- and not more than Rs. 10,000/- ; and
- c) that this notification shall be effective from 08.07.2009.
