3. Demand:-

They have represented that:

- (i) Vide order no. F16 (16) FD/Rules/98 dated 19.9.98 Government has revised pay scales of Vidhi Rachna State and Subordinate Services, and granted them higher pay scales. Pay scales of Legal Service were not revised The duties of a Vidhi Rachna Service employee include translation. They enjoy higher pay scales compared to Legal Service. This difference in pay scales is not justified. Legal Service holders own more responsibility and perform harder duties.
- (ii) Government did not grant parity in pay scale with Central Government while adopting 5th Pay Commission pay scales.
- (iii) Pay Scale and grade pay should be given at par with the Central Government.
- (iv) In Writ Petition No.3452/2006, dated 12.9.2006, Hon'ble High Court had directed that the recommendations of Yatindra Singh Committee and representation of this service may be decided within three months.
- (v) Cabinet also deferred a decision on the pay scales in view of the recommendations of VI CPC to be received soon. As State Government has not complied Hon'ble Court decision, they have filed a contempt writ before the Court.
- (vi) They have given list of work performed by them.

(iii) Back ground of Vidhi Rachnakar:

Vidhi Rachna Service was established in 1981 based on the recommendation of Singhvi Committee. Main duties and responsibilities of Vidhi Rachnakar is translation from English to Hindi and vice-versa of Press communiqués, Press Article, Government Resolution, Legislation, Rules and instructions and to explain common expression, cliches, etc. in use in such compositions.

II - Views of the Committee

- (iv) The demand of the Vidhi Sewa Officers for parity in scale with the comparable posts in Vidhi Rachana Service has been considered by the Committee. Vidhi Rachana Service has been encadred in Secretariat service. Like Secretariat service it is a closed cadre. Secretariat, Raj Bhawan, High Court and RPSC enjoy special status and the employees serving in these organizations are also granted special pay and higher pay scales. The pay scales in these organizations have been determined keeping in view the special nature of duties. Therefore the pay scales of the Law service cannot be compared with analogous posts in Vidhi Rachana Service.
- (v) The promotional avenues in Legal Services are more than Vidhi Rachana Service or the Prosecution Service on account of levels in these services. Of these, the qualifications for entry into Prosecution Services is higher. Therefore comparison of their services with a closed cadre service like Vidhi Rachnakar or Prosecution Service which has a higher entry level qualification, is not fair. In view of the above facts there is no case for revision of the pay scales of Legal Service Officers.
