Demand:-

They have represented that:

- (i) Central 5th Pay Commission had recommended pay scale of Rs.6500-10500 for Law Degree Holders, 6th Central Pay Commission has recommended grade pay Rs.4600 at entry level, but State Government has given grade pay Rs.3600. Grade pay should be given at par with Central Government.
- (ii) For Legal Service and Vidhi Rachna Service, the minimum prescribed qualification is Law Degree, whereas for Prosecution Service besides Law Degree, two years' experience as advocate is also required. Yet, there is a difference in their pay scales. Therefore, the scales of Public Prosecutors should be higher than those of other Legal Services.
- (iii) Pay scale of first promotion post in Prosecution Service is identical to other Legal Services, but the pay scale of second promotional post is lower than the pay scale admissible to Vidhi Rachna Service. Pay scale of the third promotion post is lower than both the Legal Service and Vidhi Rachna Service. This anomaly should be corrected.

4. Factual Position and views of the Committee:-

I - Factual Position

(i) Director, Prosecution has confirmed that besides Bachelor's degree in law, 2 years of experience as advocate is also required for appointments in Prosecution Service. In D.B. Civil Writ

petition No.9045/2002, filed by Rajasthan Assistant Public Prosecutor and others v/s Government of Rajasthan, Hon'ble High Court has directed (on 6.11.2008) that the petitioners may file a representation for removal of pay anomaly and State Government may decide the pay anomaly within three months.

- (iv) Comparative Statement of method of appointment and Qualification in Prosecution, Legal and Vidhi Rachna Services are as follows:
- (v) Sixth Pay commission in its report has recommended that:-"7.24.12 - Assistants (Legal) in Department of Legal Affairs have demanded a higher pay scale of Rs.8000-13500 on the ground that they perform specialized duties. The post is presently in the pay scale of Rs.6500-10500. Post of Assistant (Legal) is a feeder post to that of Superintendent (legal) that exists in the pay scale of Rs.7500-12000. The pay scale of Rs.10000-15200 has been demanded for the post of Superintendent (Legal). The scale is attached to Grade IV of Indian Legal Service which is a Class-I service. Clearly, this scale cannot be granted without upsetting the existing relativities. Similarly, the scale of Rs.8000-13500, being the entry level pay scale for Group A posts, can not be extended to the posts of Assistant (Legal). The duties attached to the posts also do not justify the higher pay scales being demanded. However, the Commission, as a general rule, has recommended pay scale of Rs.7450-11500 for posts requiring minimum qualification of a degree in law. This will need to be extended in case of Assistants (Legal) as well. The Commission recommends that the post of Assistant (Legal) should be upgraded and placed in the next higher grade of Rs.7450-11500 corresponding to the revised pay band PB-2 of Rs.8700-34800 along with grade pay of Rs.4600. Superintendents (Legal) shall be accorded the normal replacement pay band and grade pay."
- "7.57.30- Higher pay scales have been demanded for the cadre of public Prosecutor in Directorate of prosecution on the ground that minimum qualifications for these posts is a degree in Law and, therefore, these should be treated on par with Doctors. The parity with medical Doctors is not justified. The Commission, as a general policy, has recommended the scale of Rs. 7450-11500 for all posts other than in Group A carrying minimum qualification of a degree in Law. This will need to be extended here as well. The post of Public prosecutor shall, therefore, be placed in the entry

II - Views of the Committee

(vi) The Rajasthan Abhiyojan Adhikari Association has represented to the Committee for grant of pay scale and grade pay at par with Central Government. They have further contended that their pay scale should be higher than Legal and Vidhi Rachana Service in view of their higher qualification at entry level. (vii)The Committee gave thoughtful consideration to the contents of the representation submitted before it. In order to appreciate their representation in correct perspective, a chart indicating their

- (viii) From perusal of the above chart it is evident that the post of Assistant Public Prosecutor-II, Legal Assistant and Vidhi Rachanakar are 100% direct recruitment posts with law degree as an essential qualification. The initial entry level qualification for Assistant Public Prosecutor-II requires besides, graduation in law, two years of experience at bar also. From the table quoted above it is evident that the pay scale of the 3rd promotion post in Prosecution Service is lower.
- (ix) The Committee has considered the demands of the Association. The primary demand of the Prosecution Service is that they come through the same competitive examination with same qualifications as their other counterparts in the Legal Service and yet their pay scales are lower than those of other comparable post. This is so despite the fact that they are required to possess two years experience at the entry level.
- (x) As regards the demand of Prosecution Service for parity with Vidhi Rachana Sangathan it would be appropriate to mention here that Vidhi Rachana Sangathan has been encadred in Secretariat Service. Like Secretariat Service, it is also a closed cadre. Secretariat, High Court, RPSC have been assigned special status in view of specialized nature of duties of the employees working therein. Therefore, the pay scales in the Secretariat given to Vidhi Rachana Sangathan can not be compared with those in Prosecution Service. However, keeping in mind the higher entry level qualifications prescribed in Prosecution Service, the Committee is of the view that a fair comparison is warranted between the pay scales of Prosecution Service and those in Law Service.
- (xi) The initial entry level qualification in prosecution is higher than that of entry level qualification in law service. Besides Law Degree, two years experience is also required at entry level in Prosecution Service. Their first and second promotion scales are identical with those of Law Service but their third

अप्ति स्थियात्त्व, जयपुर वित्र (नियम) विस्त्र वित्र (नियम) विस्त्र promotional scale i.e. on the post of Deputy Director is in the pre-revised pay scale of 10650-15850 grade pay 6800, whereas the third promotional post in Law Service is in the pre-revised pay scale of 11300-16200 with grade pay 7200. The Committee therefore, recommends that the pay scale of the post of Deputy Director, Prosecution may be revised to 11300-16200 (pre-revised) grade pay 7200 at par with Law Department post of Legal Remembrancer.

(xii) As regards their contention for grant of grade pay of 4600 at par with analogous post in Government of India, it would be pertinent to mention that the State Government has taken no decision to grant higher pay scale to holders of Engineering and Law degree because of its functional requirements. The functional requirements of the State and Centre are totally different. The State Government, therefore, has rightly granted replacement pay scales. There is therefore, no force in this demand.
